P.B. College Gauripur has established a robust system for addressing grievances redressal mechanism through a statutory body '**Grievance Redressal Cell**'. The policy document of the cell aims at redressing the grievances of the students. Besides this cell the college has 'Internal Complaint Committee' and Ant-Ragging committees which are the statutory body. The students and other members of the college community can register their complaints with the appropriate committee based on the nature and seriousness of the grievances.

During the Academic session 2022-2023 the grievance redressal committee received altogether 90 (ninety) complaints and all of them were related to examination. The applications were forwarded to the Examination Cell for its timely redressal. Accordingly, the grievances were examined by the Examination Cell of the college and they were redressed.

Since the Principal of the college is the Chairperson of the Cell, he personally took initiative to forward some of the applications to the competent authority of the affiliating university for its timely redressal. The Coordinator of Examination Cell also took initiative for urgent resolution.

Most of the issues of grievances were reported to the teaching departments of the college and they were related to students' absences from internal exams or dissatisfaction with their marks in these Exams. Departments, in consultation with the Examination Cell, conducted internal exams and prioritized student complaints related to internal marks. Evaluated answer scripts were provided to students to address any discrepancies, with faculty members reviewing issues to ensure fairness.

These complaints were taken seriously, and the Examination Cell timely resolved all the grievances. The Anti Ragging Committee and Internal Complaint Committee received no grievances during the Academic Year 2022-2023. The list of the grievances as mentioned in the Grievance Register are attached herewith this report.

ANTI RAGGING POLICY

With a notion of preventing and stopping the ragging activities in college and hostel premises and as per the directives of the UGC, an Anti Ragging Cell/Squad has been constituted.

A close liaison with the students' union and the squad members is maintained so that sensitivity & prevention of ragging in the new sessions can be achieved. Every year the college distributes leaflets containing the names of the entire Anti ragging squad and Anti ragging cell members along with their cell numbers among the freshmen. In front of College premises and hostels, there are holders containing the Anti-ragging act and punishments are hanged. Also, small holders of anti-ragging are displayed in classroom areas and sensitive areas.

Since its inception the cell has been rendering services in fulfilling its aims and thereby to create congenial atmosphere among the students community. Since then, it has been organizing different programmes and activities within the college compound to give awareness messages as well as new information to the newly enrolled students in each new academic session. Ragging is strictly banned in the college premises. If anybody is found indulging in such activities then cell will initiate strict action on that student irrespective of the students and guardian background.

Further during the admission process an undertaking in the prescribed format from each admitted student, which is mandatory, is collected. From 2021, as per UGC guidelines DO. No F.3-2/2021 (ARC) dated 7 October, 2021, online anti ragging undertakings are taken from students through www.antiragging.in and www.amanmovement.org which are uploaded in college website.

Aims and Objective:

1. To prevent and eliminate any ragging activities in the College and also to take proper action against those who are involved in it.
2. To spell out appropriate exemplary punishments to those found guilty.




3. To root out all its forms from the college, the institution cell will take various prohibition and prevention activities by following the different provisions of the Regulations of Supreme Court, UGC and College.
4. To organize timely student awareness programs.
5. To prevent any act of Indiscipline, Teasing or Handling with Rudeness.
6. To prevent any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
7. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
8. Any Act of abuse by spoken words, emails, SMS or public insult etc.
9. Any Act of injury or infringement of the fundamental right to the human dignity.
10. Any unlawful assembly or conspiracy to ragging.
11. To aware the students of dehumanizing effect of ragging inherent in its perversity.
12. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished

Principles of the Tobacco Free Campus Policy:

India is one of the countries having highest rates of oral cancer in the world and tobacco is responsible for a significant amount of morbidity and mortality among middle-aged population. As per the Revised Guideleines for Tobacco Free Educational Institution of the Ministry of Health and Family welfare, the Government of India, Pramathesh Barua College, Gauripur has declared the college campus as "Tobacco-Free Campus". For the same, the college has devised a policy and certain awareness programmes have also been organized in and outside of the campus against tobacco consumption.

Objectives of the Policy:

1. To create awareness amongst students and staff as well as the local community with regard to the negative impact of tobacco consumption etc.
2. To inculcate the habit of avoiding tobacco.
3. To promote tobacco free college campus.
4. To promote awareness among the community people of the locality and other institute as well.
5. To organize programmes with the Govt. for the purpose of tobacco free environment.


